VIII). Considering the Evaluation Report, the Principal Judicial Officer shall take appropriate action as he/she deems fit.

IX). No participant judge will be exempted from attending the training, except in cases of emergencies, which will be decided solely by the Registrar General of the High Court of Gujarat based on the cause and proofs attached with the exemption request.

X). The Judicial Officer shall normally avail Journey Period for the Distance between the Headquarter of Judicial Officer and Gujarat State Academy, Ahmedabad, as mentioned below:-
