The following are the terms and conditions:-

- (1) They should be treated on duty during the period of the training as aforesaid including period of journey both ways, as per Instruction No.(VIII) **with permission to leave headquarter.**
- (2) They will be entitled to Traveling Allowance / Daily Allowance as admissible under the Rules and Orders for the time being in force, subject to Instruction No.(VIII).
- (3) The posts held by them be kept vacant during the said period.

I. **Subjects:** During the workshop following subjects would be discussed:

2	Intricacies involved in jurisdiction of Civil Court in relating to intested and testamentary succession under personal law as well as Indian Succession Act.
3	Devaluation of interest in coparcenary property.
4	Concept of probate, Letter of Administration, Succession Certificate, heirship certificate
5	Intricacy related to testamentary document, gift etc.
6	How to prove will under Indian Succession as well as Evidence Act
7	Revocation Probates, letter of succession, succession certificate etc.
8	Jurisdiction of testamentary court
9	Nature, scope and power of testamentary court proceeding
10	Applicability of Limitation Act testamentary proceeding
11	Concept of living will.
12	Role of a civil court after passing preliminary decree under partition suit.

13	Execution of decree and order relating to Succession matters
14	Use of video conferencing under the Gujarat High Court Rules for Video Conferencing for Courts (High Court and Subordinate e-courts) 2021.
Moreover, the Academy may modify, add, alter or subtract the subjects/topics considering the availability of time, faculty, needs of the participant Judges, or/and other exigency, if any.	

- II. To report on **31.08.2023 at 09.30 a.m.** at the Gujarat State Judicial Academy, Behind High Court of Gujarat, Sola, Ahmedabad.
- III. To attend the training in full uniform.
- IV. To intimate Academy at least 48 hours in advance on Phone 079-27664601-15, Extension – 455, for availing accommodation at the Hostel of Academy, if required. The accommodation will be provided to the participant only and not before 24 hours from the reporting time.
- V. To bring with themselves, fully charged laptops allotted to them by the High Court.
- VI. To submit detailed report containing following parameters directly to Principal Judicial Officer for perusal and guidance within 07 days after attending the training.
- Introduction
 - Evaluation of Experience in detail, on each subject discussed during the training
 - Self-participation
 - Usefulness of the Course
 - General observations & suggestions
 - Conclusion
- Such report shall not be required to send to the Academy.
- VII. Considering the Evaluation Report, the Principal Judicial Officer shall take appropriate action as he/she deems fit.

VIII. The Judicial Officer shall normally avail Journey Period for the Distance between the Headquarter of Judicial Officer and Gujarat State Academy, Ahmedabad, as mentioned below:-

•	Less than 50 kms.	Not entitled for journey period
•	More than 50 kms. to 200 kms.	Half day journey period
•	More than 200 kms.	One day journey period
•	In case, if Holiday / Public Holiday occurs in the prefix / suffix, no Journey Period shall be admissible and Journey is to be performed in all the above cases on holiday.	

- IX. No participant judge will be exempted from attending the training, except in cases of emergencies, which will be decided solely by the Registrar General of the High Court of Gujarat based on the cause and proofs attached with the exemption request.
