The following are the terms and conditions:-

- (1) They should be treated on duty during the period of the training as aforesaid including period of journey both ways, as per Instruction No.(ix) **with permission to leave headquarter.**
- (2) They will be entitled to Traveling Allowance / Daily Allowance as admissible under the Rules and Orders for the time being in force, subject to Instruction No.(ix).
- (3) The posts held by them be kept vacant during the said period.

I. **Subjects:** During the workshop following subjects would be discussed:

(1) Medical Jurisprudence	
1	Meaning and kind of Medical Evidence. Documentary evidence - Injury Certificate, Indoor and Outdoor case papers, Laboratory Report, X-Ray, PM Report, Ossification Test, Dying Declaration etc., its Recording and appreciation of medical evidence.

2	Important aspect of Injury, Contents of MLC, Examination of Rape victim, Medical Condition during treatment in all cases, Medico legal endorsements, over view of Laboratory test and X-rays findings
3	Securing the presence of a Medical Witness.
4	Admissibility (relevancy) of medical evidence - Oral & Documentary.
5	Mode of examination of experts and its scope- Competency of Expert, Deposition of medical witness as special witness
6	Opinion in Text, Muddamal, etc. and its Recording and Appreciation of medical evidence.
7	Dying Declaration – Role of Medical Officer.
8	Hypothetical question.
9	Voluntary statement or suggestion.
10	Claim as to privilege of professional secret.
11	Refresher of expert's memory - PM Report, Age Certificate, etc.
12	Important aspect of suicidal death - Burn Injury, Poison Symptoms - organic/ inorganic poison , Strangulation by Hanging
(2) Toxicology – Organic / Inorganic poisons	
1	Toxicology organic/ inorganic poison - Organo Phosphorous
2	Aluminum Phosphate
(3) Human Anatomy – Kinds of injuries and post-mortem report	
1	Rigor Mortis
2	Post-mortem Staining
3	Lividity
4	Firearm injuries
5	Strangulation / hanging
6	Charring / Scorching
7	Nature of Injuries – Fire arm, incised, Stab
8	Duration of Death / injuries / Change of colour
9	Anti mortem / post-mortem injuries
Note: The Academy may modify, add, alter, substitute or subtract the subjects/topics according to exigency.	

- II. To report on **16.01.2023 at 09.30 a.m.** at the Gujarat State Judicial Academy, Behind High Court of Gujarat, Sola, Ahmedabad.
- III. To attend the training in full uniform.
- IV. To intimate Academy at least 48 hours in advance on Phone 079-27664601-15, Extension – 455, for availing accommodation at the Hostel of Academy, if required. The accommodation will be provided to the participant only and not before 24 hours from the reporting time.
- V. To follow all Covid-19 Protocols/Guidelines issued by Government/Hon'ble Gujarat High Court.

- VI. To bring with themselves, laptops allotted to them by the High Court.
- VII. To submit **detailed report** containing following parameters directly to Principal District Judge for perusal and guidance **within 07 days** after attending the training. Such report shall not be required to send to the Academy:
- Introduction
 - Evaluation of Experience in detail, on each subject discussed during the training
 - Self-participation
 - Usefulness of the Course
 - General observations & suggestions
 - Conclusion
- VIII. Considering the Evaluation Report, the Principal Judicial Officer shall take appropriate action as he/she thinks fit.
- IX. The Judicial Officer shall normally avail Journey Period for the Distance between the Headquarter of Judicial Officer and Gujarat State Academy, Ahmedabad, as mentioned below:-

•	Less than 50 kms.	Not entitled for journey period
•	More than 50 kms. to 200 kms.	Half day journey period
•	More than 200 kms.	One day journey period
•	In case, if Holiday / Public Holiday occurs in the prefix / suffix, no Journey Period shall be admissible and Journey is to be performed in all the above cases on holiday.	

- X. No exemption shall be granted to any of the participant judges except in case of emergency which will be decided solely by the Registrar General of High Court of Gujarat based on cause and proofs attached with exemption request.
