- (3) The posts held by them be kept vacant during the said period.

- I. **Subjects:** During the workshop following subjects would be discussed: (Participants are kindly requested to come with preparation).

1	Social perspective - Understanding relationships and conflicts between husband and wife and their respective families,
2	Psychological aspects - Counseling of husband / wife / respective families in resolving Family disputes
3	Matrimonial litigations – void and voidable marriages, restitution of conjugal rights, judicial separation and divorce, Relief of injunctions in Matrimonial proceedings
4	Divorce application filed by way of mutual consent – effect of withdrawal of consent during pendency of such application, waiving of cooling off period
5	Matrimonial litigations - laws relating to Hindu, Muslim, Christian, Shikhs on these subjects
6	Maintenance – wife, children and parents, interim relief and permanent alimony under various personal laws, Status and Rights of women who are in live-in relationships
7	Defenses available to the opponent / husband in matrimonial matters
8	Circumstances in which a Foreign Decree in a matrimonial dispute can be challenged by way of a suit
9	Provisions pertaining to Domestic Violence Act and implementation of orders passed there under
10	Custody / shared custody / joint custody of Child under various laws
11	Implications of the judgment of the Hon'ble Apex Court pertaining to Triple Talaq
12	Special provisions pertaining to matrimonial offences against women in IPC, Cr.P.C. and other Act - The Code of Criminal Procedure, 1973, The Protection of Women from Domestic Violence Act, 2005, The Hindu Adoptions and Maintenance Act, 1956, The Hindu Marriage Act, 1955, The Parsi Marriage and Divorce Act, 1936, The Divorce Act, 1869, Uncodified Muslim personal law, Muslim Women (Protection of Rights on Divorce) Act, 1986, Maintenance and Welfare of Parents and Senior Citizens Act, 2007, Special Marriage Act, 1954
13	Direction of Hon'ble Supreme Court or High Court on Gender Issues
N.B.: The Academy may modify, add, alter, substitute or subtract the subjects / topics according to exigency.	

- II. To report, on **30.01.2023 at 09.45 a.m.** at the Gujarat State Judicial Academy, Behind High Court of Gujarat, Sola, Ahmedabad.
- III. To attend the training in full uniform.
- IV. To intimate Academy at least 48 hours in advance on Phone 079-27664601-15, Extension – 455, for availing accommodation at the Hostel of Academy, if required. The accommodation will be provided to the participant only and not before 24 hours from the reporting time.
- V. To come with Chromebook fully charged.
- VI. To follow all Covid-19 Protocols/Guidelines issued by Government/Hon'ble Gujarat High Court.

- VII. To submit detailed report containing following parameters directly to Principal Judicial Officer for perusal and guidance within 07 days after attending the training. Such report shall not be required to be sent to the Academy:
- Introduction
 - Evaluation of Experience in detail, on each subject discussed during the training
 - Self-participation
 - Usefulness of the Course
 - General observations & suggestions
 - Conclusion
- VIII. Considering the Evaluation Report, the Principal Judicial Officer shall take appropriate action as he/she thinks fit.
- IX. The Judicial Officer shall normally avail Journey Period for the Distance between the Headquarter of Judicial Officer and Gujarat State Academy, Ahmedabad, as mentioned below:-

•	Less than 50 kms.	Not entitled for journey period
•	More than 50 kms. to 200 kms.	Half day journey period
•	More than 200 kms.	One day journey period
•	In case, if Holiday / Public Holiday occurs in the prefix / suffix, no Journey Period shall be admissible and Journey is to be performed in all the above cases on holiday.	

- X. No exemption shall be granted to any of the participant judges except in case of emergency which will be decided solely by the Registrar General of High Court of Gujarat based on cause and proofs attached with exemption request.
- XI. The Principal Judicial Officer, wherefrom the Judicial Officers are to attend the training, are requested to forward queries, if any, on the subject, to the Academy, directly, on or before 24.01.2023 in soft copy only, through email at gsja-guj@nic.in.
