[A] The following are the terms and conditions:-

- (1) The Judicial Officer should be treated on duty during the period of the training as aforesaid including period of journey both ways, as per condition No.(3) **with permission to leave headquarter.**
- (2) The Judicial Officer will be entitled to Traveling Allowance / Daily Allowance as admissible under the Rules and Orders for the time being in force, subject to condition No.(3).
- (3) **The Judicial Officer shall normally avail Journey Period for the Distance between the Headquarter of Judicial Officer and Gujarat State Academy, Ahmedabad, as mentioned below:-**

→	Less than 50 kms.	Not entitled for journey period
→	More than 50 kms. to 200 kms.	Half day journey period
→	More than 200 kms.	One day journey period
→	In case, if Holiday / Public Holiday occurs in the prefix / suffix, no Journey Period shall be admissible and Journey is to be performed in all the above cases on holiday.

[B] Topic & Subjects:

During the Workshop following subjects would be discussed. Participants are requested to come with preparation:-

Sr. No.	Topics
1.	Legal aid defence counsel system and early access to justice at pre-arrest, arrest and remand stage.
2.	Role of DLSAs in strengthening court based legal aid and clinic based legal services.
3.	Financial management and utilization certificates relating to grants from NALSA and GSLSA n expenditure.
4.	Use of LSMS monthly, bi-monthly and quarterly reports.
5.	Victim compensation applications.
6.	Open House Discussion – Challenges and difficulties faced by DLSAs.
7.	Appraisal of various NALSA Schemes.

Note: The Academy / GSLSA may modify, add, alter, substitute or subtract the subjects/topics accordign to exigency.

[C] To submit **detailed report** containing following parameters directly to their Chairman, DLSA for perusal and guidance within 07 days after attending the Workshop. Such report shall not be required to be send to the Academy.

- a) Introduction.
- b) Evaluation of Experience in detail, on each subject discussed during the training.
- c) Self-participation.
- d) Usefulness of the Course.
- e) General observations & suggestions
- f) Conclusion.

Considering the Evaluation Report, the Chairman DLSA shall take appropriate action as eh thinks fit.

[D] **No exemption shall be granted to any Full-Time Secretary / Part-Time Secretary except with the prior permission of Hon'ble Executive Chairman, GSLSA in exceptional circumstances.**

[E] To follow all Covid-19 Protocols/Guidelines issued by Government/ Hon'ble Gujarat High Court.

- (1) To report on 29.08.2022 at 09.00 A.M. at the Gujarat State Judicial Academy, Behind High Court of Gujarat, Sola, Ahmedabad.

- (3) To intimate Academy at least 48 hours in advance on Phone: 079-27664601-15, Extension-455, for availing accommodation at the Hostel of Academy, if required. The accommodation will be provided to the participant only and not before 12 hours from the reporting time.
