Subjects: During the Training Programme following subjects would be discussed and participants are requested to come with preparation:-

Sr. No.	Topics
1	Intricacies involved in intestate and testamentary succession under personal law as well as Indian Succession Act.
2	Devolution of interest in coparcenary property, under Hindu Succession Act.
3	Concept of living will.

Note: The Academy may modify, add, alter, substitute or subtract the subjects/topics according to exigency.

Instructions:

- I. To register online on **first day of the web-workshop at 09:45 A.M.** as directed by GSJA through Zoom app. In case any difficulty is found in connecting or registering contact System Officer/Nodal Officer or IT Department of the concerned district. - II. To register with their official names/designation while attending the web-workshop. (No participant judge should attend the web workshop with the phone name or any illusive names)
- III. The presentation and material shared during training sessions by resource person would be provided through whatsapp group to the participants.
- IV. During the training programme, Google Forms for feedback will be sent to the participants. Upon the completion of the training programme, the participant have to fill up the feedback in this Google Forms and has immediately to send back to the academy so that upcoming training programme can be properly framed and improved.
- V. It is incumbent to join web-workshop through laptop/desktop/computer/tablet only. Without prior permission of GSJA, joining web-workshop through mobile phone is not permissible.

VI. It is on duty training programme. Accordingly, Principal District Judges shall make necessary charge arrangement.

VII. To attend the training in full uniform.

VIII. There could be group discussion/case study during the training session amongst participant Judges. The group of participants will be decided in advance and also case material for group discussion shall be provided in advance during training programme. The group of participants shall have to present their view through anyone chosen by Gujarat State Judicial Academy, on the subject given in case study.

X. No exemption shall be granted to any of the participant judges except in case of emergency which will be decided solely by the Registrar General of High Court of Gujarat based on cause and proofs attached with exemption request.

XI. Judicial Officer mentioned at Sr.No.12 may be granted the benefit as mentioned in High Court Letter No.A.3502/2021 dated 13.07.2021 during the course of training period.
