**The following are the terms and conditions:-**

- (1) They should be treated on duty during the period of the training as aforesaid including period of journey both ways, as per Instruction No.(viii) with permission to leave headquarter.
- (2) They will be entitled to Traveling Allowance / Daily Allowance as admissible under the Rules and Orders for the time being in force, subject to Instruction No.(viii).
- (3) The posts held by them be kept vacant during the said period.

**Subjects:** During the Training Programme following subjects would be discussed. Participants are requested to come with preparation:-

Sr.	Topics
1	Intricacies involved in intestate and testamentary succession under personal law as well as Indian Succession Act.
2	Devolution of interest in coparcenary property, under Hindu Succession Act.
3	Concept of living will.

Note: The Academy may modify, add, alter, substitute or subtract the subjects/topics according to exigency.

**Instructions:**

- I. To report on **06.01.2022** at **09.45 a.m.** at the Gujarat State Judicial Academy, Behind High Court of Gujarat, Sola, Ahmedabad.
- II. To attend the training in full uniform.

- III. To intimate Academy at least 48 hours in advance on Phone 079-27664601-15, Extension – 455, for availing accommodation at the Hostel of Academy, if required. The accommodation will be provided to the participant only and not before 12 hours from the reporting time.
- IV. There could be group discussion/case study during the training session amongst participant Judges. The group of participants will be decided in advance and also case material for group discussion shall be provided in advance with start of training programme. The group of participants shall have to present their view through leader on the subject given in case study.
- V. To follow all Covid-19 Protocols/Guidelines issued by Government/Hon'ble Gujarat High Court.
- VI. To submit **detailed report** containing following parameters directly to Principal District Judge for perusal and guidance **within 07 days** after attending the training. Such report shall not be required to send to the Academy:
- (a) Introduction
  - (b) Evaluation of Experience in detail, on each subject discussed during the training
  - (c) Self-participation
  - (d) Usefulness of the Course
  - (e) General observations & suggestions
  - (f) Conclusion
- VII. Considering the Evaluation Report, the Principal District Judge shall take appropriate action as he thinks fit.
- VIII. **The Judicial Officer shall normally avail Journey Period for the Distance between the Headquarter of Judicial Officer and Gujarat State Academy, Ahmedabad, as mentioned below:-**

→ Less than 50 kms.	Not entitled for journey period
→ More than 50 kms. to 200 kms.	Half day Journey period
→ More than 200 kms.	One day journey period
→ In case, if Holiday / Public Holiday occurs in the prefix / suffix, no Journey Period shall be admissible and Journey is to be performed in all the above cases on holiday.	

- IX. No exemption shall be granted to any of the participant judges except in case of emergency which will be decided solely by the Registrar General of High Court of Gujarat based on cause and proofs attached with exemption request.
