- III. The presentation and material shared during training sessions by resource person would be provided through whatsapp group to the participants.
- IV. During the training programme, Google Forms for feedback will be sent to the participants. Upon the completion of the training programme, the participant have to fill up the feedback in this Google Forms and has immediately to send back to the academy so that upcoming training programme can be properly framed and improved.
- V. It is on duty training programme. Accordingly, Principal District Judges shall make necessary charge arrangement.
- VI. To attend the training in full uniform.
