2	Important aspect of Injury, Contents of MLC, Examination of Rape victim, Medical Condition during treatment in all cases, Medico legal endorsements, over view of Laboratory test and X-rays findings
3	Securing the presence of a Medical Witness.
4	Admissibility (relevancy) of medical evidence - Oral & Documentary.
5	Mode of examination of experts and its scope- Competency of Expert, Deposition of medical witness as special witness
6	Opinion in Text, Muddamal, etc. and its Recording and Appreciation of medical evidence.
7	Dying Declaration – Role of Medical Officer.
8	Hypothetical question.
9	Voluntary statement or suggestion.
10	Claim as to privilege of professional secret.
11	Refresher of expert's memory - PM Report, Age Certificate, etc.
12	Important aspect of suicidal death - Burn Injury, Poison Symptoms - organic/ inorganic poison, Strangulation by Hanging
