
Following subjects will be discussed during the **Workshop**.

2.	Trials – Recording and appreciation of evidence under POCSO Act – Special duty of Public Prosecutor for compensation.
3.	Dealing with the most vulnerable section of population – children - victims of sexual harassment – knowing child psychology by Special Courts for effective child friendly atmosphere – hurdles – social and legal for rendering justice to child victim.
