I. **Subjects:** During the web-workshop following subjects would be discussed:

Sr. No.	Subjects
1	Object of N.I. Act, Ingredients of offence under Section 138 of N.I. Act. Nomenclatures of cheque and issues associated with it. Insufficient of funds and other endorsement.
2	Intimation of Dishonor of cheque. Notice. Presumption as to proof of service of notice, consolidated notice, notice on company/firm, contents of notice, person authorized to receive notice, limitation period for notice, etc.
3	Complaint, delay and condonation of delay, cognizance and jurisdiction and Offences by Company.
4	Trial Procedure – Summary trial/summons trial, service of summons/ warrant. Evidence by complainant side and accused side. Further statement. Addition of party and Cr.P.C. Sec. 319.
5	Recording of evidence, passing an order under section 143A, application by complainant to give exhibit to the documents and endorsement of accused on the complaint or on separate application. Arguments etc.
6	Appreciation of evidence - Presumptions under N.I. Act & Evidence Act, burden and onus of proof, applicability of reverse onus clause, standard of proof.
7	Compounding of offence in and out of Lok Adalat, Penology – Sentence and fine, compensation-interest cost and Govind kutti and M/s. Meters and instrument judgment. Bottlenecks in disposal of cases etc.
