The following are the terms and conditions:-

- (1) They should be treated on duty during the period of the training as aforesaid including period of journey both ways, as per Note under Instruction No.(vii). **with permission to leave headquarter.**
- (2) They will be entitled to Traveling Allowance / Daily Allowance as admissible under the Rules and Orders for the time being in force, subject to Instruction No.(vii).
- (3) The posts held by them be kept vacant during the said period.

INSTRUCTIONS :

- I. To report on **12/03/2020** at **09.30 a.m.** at the Gujarat State Judicial Academy, Behind High Court of Gujarat, Sola, Ahmedabad.
- II. To attend the training in full uniform.
- III. To intimate Academy at least 48 hours in advance on Phone 079-27664601-15, Extension – 455, for availing accommodation at the Hostel of Academy, if required. The accommodation will be provided to the participant only and not before 12 hours from the reporting time.
- IV. All the drivers of the trainee Judicial Officers who are entitled to the official car and the driver will be entitled to have accommodation at the driver dormitory subject to the condition that the concerned driver shall not cause any filth at the dormitory and shall maintain the clearness and hygiene of the campus.
- V. To submit **detailed report** containing following parameters directly to Principal District Judge for perusal and guidance **within 07 days** after attending the Workshop. Such report shall not be required to send to the Academy:
 - a) Introduction
 - b) Evaluation of Experience in detail, on each subject discussed during the training
 - c) Self-participation
 - d) Usefulness of the Course
 - e) General observations & suggestions
 - f) Conclusion
- VI. Considering the Evaluation Report, the Principal District Judge shall take appropriate action as he thinks fit.
- VII :**The Judicial Officer shall normally avail Journey Period for the Distance between the Headquarter of Judicial Officer and Gujarat State Academy, Ahmedabad, as mentioned below:-**

❖	Less than 50 kms.	Not entitled for journey period
❖	More than 50 kms. to 200 kms.	Half day journey period
❖	More than 200 kms.	One day journey period
❖	In case, if Holiday / Public Holiday occurs in the prefix / suffix, no Journey Period shall be admissible and Journey is to be performed in all the above cases on holiday.
