2. The following are the terms and conditions:

- They should be treated on duty during the period of the Training Programme as aforesaid including the period of journey, with permission to leave headquarter.
- Expenses: The expenses incurred at the Gujarat State Judicial Academy (GSJA) for conducting workshop for the Participants will be borne by the GSJA out of the grant available to the GSJA. The rest of the expenses TA/DA, etc. as admissible under the rules will be borne by the Revenue Department. The same will be debited and met from the grant sanctioned under the Head of Pay and Allowances payable which is applicable to them.
- The posts held by them are kept vacant during the above period.
- In case of change of the batch or non-attending of training due to personal/ unavoidable circumstances i.e. Exemption, leave, rearrangement of training etc. will be granted by the Director, GSJA and intimated to the Revenue Department after completion of workshop of all batches.
