The following are the terms and conditions:-

1. They should be treated **on duty during the period of the aforesaid Programme** including period of journey both ways, as per **Instruction No. (13) with permission to leave headquarter.**
2. They will be entitled to **Traveling Allowance/Daily Allowance** as admissible under the Rules and Orders for the time being in force, subject to **Instruction No. (13).**
3. The posts held by them be kept vacant during the said period.
4. Those participants who stay in the Hostel of Academy shall have to attend morning Yoga Session.
5. To report on **10.06.2026 at 08.00 a.m.** at the Gujarat State Judicial Academy, Behind High Court of Gujarat, Sola, Ahmedabad.
6. All Judicial Officers attending the programme are exempted from wearing full uniform. However, they are required to be dressed in formal attire, including a sober blazer. Their overall appearance during the programme must be formal and

dignified. The wearing of Nehru Jackets, Jeans, T-shirts, Slippers and Sandals are strictly prohibited.

7. **To intimate Academy at least 48 hours in advance on Phone 079-27664601-15, Extension – 455**, for availing accommodation at the Hostel of Academy, if required. The accommodation will be provided to the participant only and not before 24 hours from the reporting time.
8. **To bring with themselves their tablet / iPad / laptop.**
9. Arrangements of 'Charge' for the participants may be made in terms deemed fit by the Principal Judicial Officer.
10. To submit detailed report containing following parameters directly to Principal Judicial Officer for perusal and guidance within 07 days after attending the training.
 - a. Introduction;
 - b. Evaluation of Experience in detail, on each subject discussed during the Programme;
 - c. Self-participation;
 - d. Usefulness of the Course;
 - e. General observations & suggestions;
 - f. Conclusion

Such report shall not be required to send to the Academy.

11. Considering the Evaluation Report, the Principal Judicial Officer shall take appropriate action as he/she deems fit.
12. **Feedback form to be filled through Judicial Officers' Portal after completion of Programme.**
13. **The Judicial Officer shall normally avail Journey Period for the Distance between the Headquarter of Judicial Officer and Gujarat State Judicial Academy, Ahmedabad, as mentioned below:-**

•	Less than 50 kms.	Not entitled for journey period
•	More than 50 kms. to 200 kms.	Half day journey period
•	More than 200 kms.	One day journey period
•	In case, if Holiday / Public Holiday occurs in the prefix / suffix, no Journey Period shall be admissible and Journey is to be performed in all the above cases on holiday.	

14. **No participant judge will be exempted from attending the Programme, except in cases of emergencies, which will be decided solely by the Registrar General of the High Court of Gujarat based on the cause and proofs attached with the exemption request through the Director, Gujarat State Judicial Academy.**
